**RESOLUTION NO. 2018-41**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA, AMENDING RESOLUTION 2018-14 CITY OF PALMETTO PARK OPERATING HOURS AS PROVIDED FOR IN ORDINANCE 2018-01; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Article VIII, Section 2 of the Florida Constitution provides that municipalities shall have governmental, corporate and proprietary powers to enable municipalities to conduct municipal government, perform municipal functions and render municipal services; and,

**WHEREAS**, Chapter 166, Florida Statutes, the "Municipal Home Rule Powers Act," implements the applicable provisions of the Florida Constitution and authorizes municipalities to exercise any power for municipal purposes, except when expressly prohibited by law and to enact ordinances in furtherance thereof; and;

**WHEREAS**, the City Commission adopted Ordinance No. 2018-01, an Ordinance setting park operating hours for the City of Palmetto on February 26, 2018 and

**WHEREAS**, Section 3 of such Ordinance authorized the creation and from time to time review and amendment of a park operating hours in the City of Palmetto.

**NOW, THEREFORE**, be it resolved by the City Commission of the City of Palmetto, Florida, duly assembled this day:

**Section 1.** The above “whereas” clauses are hereby adopted and confirmed as findings of fact.

**Section 2.** The City Commission does hereby amend and approve the Park Operating Schedule attached hereto as **Exhibit A**.

**Section 3.** This Resolution shall take effect as provided for by law and by City Charter, Section 14, upon execution by the Mayor or, if disapproval occurs, upon reconsideration by the City Commission and passing of the Resolution by at least four (4) votes.

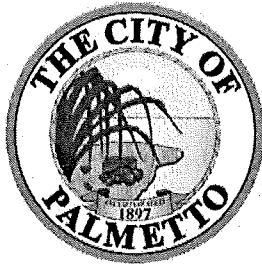

## Park Operating Hours (EXHIBIT A)

All cemetery and park facilities owned and operated by the City of Palmetto are open from 30 minutes before sunrise to 30 minutes after sunset with the following exceptions:

- Riverside Park East and West will be open 24 Hours
- Sutton Park will be open from 30 minutes before sunrise to 10 p.m.
- Lamb Park will be open from 30 minutes before sunrise to 11 p.m.
- City of Palmetto Cemetery at 900 14<sup>th</sup> Ave West will be 30 minutes before sunrise to 10 p.m.
- All walking trails in the City will be open 24 hours

All park hours can be modified via a Special Function Permit and approval by City Commission.
