In support of Manatee County's BUILD Grant for the Palmetto Trails Network, the Florida Department of Transportation (FDOT) is conducting a Project Development and Environment (PD&E) Study for the Middle and Northern Segments of the Palmetto Trails Network. We will be holding small neighborhood focus groups the weeks of February 15<sup>th</sup> and 22<sup>nd</sup>, 2021, at the locations and times indicated below. You are invited to attend one of these outdoor focus groups at your convenience or stop by to view the displays which describe the anticipated trail network and its features.

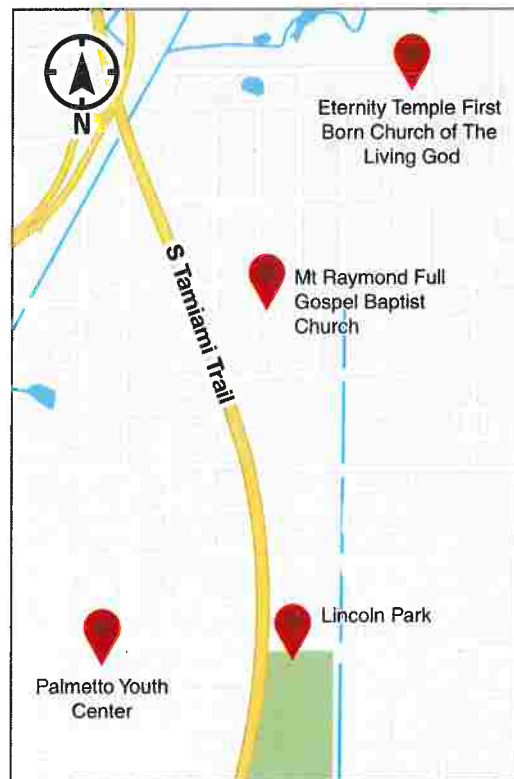

## MANATEE COUNTY BUILD GRANT

On May 22, 2018, the Manatee County Board of County Commissioners first authorized the submittal of a grant application to the USDOT for facilities intended to advance multimodal transportation options such as trails to reduce highway congestion, make significant improvements in pedestrian and automobile safety, and encourage economic development in the areas where improvements are proposed.

Manatee County articulates in their BUILD grant application the goal to ultimately provide 3.6 miles of an interconnected trail network, 65 lighting fixtures to enhance trail safety, 15 transit stop improvements, nine new or enhanced trail/pedestrian crossings, seven new connections between schools, parks, and activity centers, two additional connections between adjacent neighborhoods and Lincoln Community Park, two enhanced underpass treatments to convey the trail alignment under the heavily traveled US 41, one signature/gateway bridge (not included in this PD&E study), and one trail/pedestrian bridge.
